

## **KrisFlyer Fest Mastercard Lucky Draw Challenge Terms and Conditions** **("Terms and Conditions")**

1. This lucky draw ("**Lucky Draw**") is organised by Singapore Airlines Ltd ("**SIA**").
2. This Lucky Draw is valid from 6 June 2026, 0001hrs (GMT+8) to 7 June 2026, 2359hrs (GMT+8) ("**Promotion Period**").
3. In order to be eligible to enter the Lucky Draw, each individual must be:
  - i. both a KrisFlyer member and a registered user of the Kris+ Mobile Application ("**Kris+ App**");
  - ii. an attendee of the KrisFlyer event held at Jewel's Cloud9 Piazza on 6 to 7 June 2026 ("**KrisFlyer Fest**"); and
  - iii. aged 18 years and above as at the commencement of the Promotion Period  
(each individual fulfilling all the criteria above shall be referred to as a "**Participant**", and collectively, the "**Participants**").
4. Employees of SIA, their immediate families, affiliates, subsidiaries, related agencies, principal sponsors and suppliers associated with this campaign are not eligible to participate in the Contest. Corporations and other artificial persons are not eligible to participate in the Contest.
5. If a Participant has started the KrisFlyer Fest Mastercard Lucky Draw Challenge available on the Kris+ app ("**Challenge**") and achieves a Kris+ Minimum Spend in at least one Spend Category, such Participant shall be automatically enrolled by SIA into the Lucky Draw (such Participant shall be referred to as an "**Enrolled Participant**"). Participants shall not be permitted to enroll in the Lucky Draw by any method other than as specified in this Clause 5.
6. A Participant shall only be considered to have started the Challenge after he/she has entered the Challenge screen on the Kris+ app and tapped on "Start now" under the "KrisFlyer Fest Mastercard® Lucky Draw".
7. "**Kris+ Minimum Spend**" refers to a cumulative spend of at least SGD 30 on one or more transactions which are:
  - i. made using a Mastercard® debit or credit card, directly through the Kris+ App (regardless of type of mobile device used), at either of the following booths (each a "**Spend Category**"):
    - (a) the F&B booth and/or iron-on patch booth at the KrisFlyer Fest; or
    - (b) the KrisShop booth and/or Pelago booth at the KrisFlyer Fest; and
  - ii. carried out within the Promotional Period after starting the Challenge.

For the avoidance of doubt, the Kris+ Minimum Spend must be achieved within a single Spend Category and spend across different Spend Categories will not be aggregated. Whether the Kris+ Minimum Spend has been achieved and whether the conditions of this Clause 7 have been met shall be determined by SIA in its sole and absolute discretion.
8. Achieving the Kris+ Minimum Spend entitles the Enrolled Participant to one (1) Lucky Draw entry per Spend Category only. Any cumulative spend exceeding SGD 30 in a single Spend Category (e.g. SGD 60 or SGD 90) does not entitle the Enrolled Participant to additional Lucky Draw entries.
9. SIA will randomly select 43 winners (each, a "**Winner**", and collectively, the "**Winners**") from the Enrolled Participants, in accordance with the provisions of these Terms and Conditions and based on the number of Lucky Draw entries each Enrolled Participant has accumulated.

10. The draw will take place remotely on 12 June 2026 at 1 Changi Business Park Central 1, One@Changi City, Singapore 486036.
11. SIA will notify each Winner via the email address registered with each Winner's KrisFlyer membership profile within seven (7) working days after the draw. Each Prize (including the redemption thereof) may be subject to additional terms and conditions as may be notified to the respective Winners. Winners will be selected by randomised computerised draw. By accepting the Prize, each Winner agrees to such additional terms and conditions (as applicable).
12. Each Winner will be required to return a signed letter of acceptance in such form as SIA may prescribe via email to SIA within fourteen (14) working days from the date on which the notification email is sent, failing which, the Prize will be forfeited.
13. The results of the draw will be published within seven (7) working days after determination of the results on the KrisFlyer Fest website (available at <https://krisflyer.com/krisfest>).
14. The Prizes cannot be exchanged or redeemed for cash and shall not be transferred to another individual.
15. Each Participant is permitted to register one (1) KrisFlyer membership account in his/her name only. Any fraudulent or duplicate KrisFlyer accounts, including the original KrisFlyer account held by such Participants, will be suspended, and the relevant Participant shall be disqualified from the Lucky Draw, at SIA's sole and absolute discretion.

16. By starting the Challenge, each individual:

All decisions by SIA in respect of the choice of Winners are final.

To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment), or that results in an infringement of any law or regulation, by entering the Lucky Draw or the Participant’s acceptance of any Prize.
