

Special Giveaway with KrisFlyer and Mastercard

KrisFlyer members who participate in the 'Special Giveaway' (as defined herein) in accordance with these terms (the "**Terms**") from **12 September 2025** (1200 hrs UAE time) to **31 October 2025** (1800 hrs UAE time) ("**Special Giveaway Period**") will stand a chance to receive a special giveaway gift items.
