

KrisFlyer 800 Welcome Bonus Miles Promotion Terms and Conditions ("Terms and Conditions")

1. These Terms and Conditions govern the KrisFlyer 800 Welcome Bonus Miles Promotion (the "**Promotion**") organised by Singapore Airlines Limited ("**SIA**").
2. This Promotion will be carried out on singaporeair.com during the promotional period commencing on 10 March 2026, 0000hrs (GMT+8) and ending on 30 March 2026, 2359hrs (GMT+8) ("**Promotional Period**").
3. Participation in this Promotion is limited to those (i) who satisfy the following criteria:
 - a. Successfully signed up for a KrisFlyer membership account on singaporeair.com during the Promotional Period using the promo code '**KFHKMAR26**';
 - b. Select "**Hong Kong SAR, China**" as their country/region of residence on the KrisFlyer registration form at the point of enrolment (each, a "Participant").
4. Eligible Participants will receive 800 KrisFlyer miles each ("**Bonus Miles**"), which will be credited into their KrisFlyer accounts within four (4) to six (6) weeks of signing up.
5. This Promotion is limited to the first eight hundred (800) Participants who successfully register for a new KrisFlyer membership on a first-come, first-served basis.
6. Any KrisFlyer membership sign-ups received outside of the Promotional Period will not be considered for this Promotion, and such Participants will not earn the Bonus Miles. Each Participant is only entitled to claim the Bonus Miles once in this Promotion.
7. The Bonus Miles will be valid for a period of three (3) years from the date on which it is credited into the Participant's KrisFlyer account, following which they shall expire and no extensions will be permitted.
8. This Promotion cannot be combined with any other campaigns or promotions, including other KrisFlyer membership sign up bonus promotions.
9. Each individual is only permitted to hold one KrisFlyer membership account at any time, and any and all fraudulent or duplicate accounts, including the individual's original KrisFlyer membership account, will be suspended and disqualified from the Promotion.

By participating in the Promotion, each Participant agrees to comply with and be bound by these terms and conditions, SIA's conditions of use of website, SIA's Privacy Policy, KrisFlyer Terms and Conditions, and KrisShop Terms and Conditions (collectively, "**SIA Terms & Conditions**"). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the participant being disqualified at any stage of the Promotion, and any bonuses or prizes won may be forfeited, withheld, withdrawn or reclaimed.

The use of KrisFlyer miles to redeem hotel stays or car rentals on KrisFlyer vRooms (<https://www.krisflyervrooms.com/>) is subject to room/car availability at the time of booking and must be used in accordance with the terms and conditions of the KrisFlyer programme, and the terms of use of the KrisFlyer vRooms website (at <https://www.krisflyervrooms.com/info/termsfuse.html>).
15. The use of KrisFlyer miles to redeem for shopping, dining, wellness services via the Kris+ mobile application must be used in accordance with the terms and conditions of the KrisFlyer programme, and Kris+ partners (at <https://krisplus.com/>).
16. All decisions made by SIA, in respect to any matter relating to this Promotion shall be final. SIA reserves the right to verify the eligibility of Participants, vary these terms and conditions, terminate or otherwise amend this Promotion without prior notice at its sole and absolute discretion.
17. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by entering the Promotion or the participant's acceptance of any prize.
