

Terms and Conditions of Singapore Airlines x Citi Credit Card

Exclusive Promo Code

1. The promo code (“**Code**”) is only valid when cardholders of Citi Credit Cards issued by Citibank (Hong Kong) Limited (“Citibank”) (“Eligible Cards”) (“Cardholders”) purchase round-trip ticket from Hong Kong to any Singapore Airlines-operated destination (except North Asia) at singaporeair.com and SingaporeAir mobile app with the designated Promo Code from 1 September 2026, 0900hrs (GMT+8) to 21 September 2026, 2359hrs (GMT+8) (both dates inclusive), and settle the whole payment by respective Eligible Citi Credit Cards to enjoy HK\$200 discount per adult. Any request to apply the Code after checkout will not be accepted.
2. Promo code quotas are limited and available while quotas last. The promo code will no longer be available once the total usage limit is reached during the promotion period.
3. Only one (1) Code can be used for each transaction.
4. The promo code applied will only allow up to four passengers per booking.
5. Promo code is only applicable for outbound travel between 1 September 2026 to 30 June 2027 and travel complete on or before 31 August 2027.
