

SQ Wanderlust New Year KrisFlyer 500 Welcome Bonus Miles Promotion Terms and Conditions
("Terms and Conditions")

1. These Terms and Conditions govern the SQ Wanderlust New Year KrisFlyer 500 Welcome Bonus Miles Promotion (the "**Promotion**") organized by Singapore Airlines Limited ("**SIA**") (Unique Entity Number: 197200078R), a company incorporated in Singapore and operating via its Japan regional office ("**SIA**") and governed by these Terms and Conditions.
2. This Promotion will be carried out on https://www.singaporeair.com/en_UK/jp/plan-travel/local-promotions/sq-wanderlust/ ("**Site**") during the promotional period commencing on 15 January 2026, 0000hrs (GMT+9) and ending on 29 January 2026, 2359hrs (GMT+9) ("**Promotion Period**").
3. Participation in this Promotion is limited to participants (i) who satisfy the following criteria, i.e. the participant must:
 - a. be one of the first 1,000 new members who successfully sign up for a KrisFlyer membership account on the Site during the Promotion Period; and
 - b. enter the eligible promotion code "**KFNY26**" for the KrisFlyer 500 Bonus Miles promotion when he or she signs up as a new KrisFlyer member during the Promotion Period;
 - c. not have held KrisFlyer membership or had a KrisFlyer account in the period of two years before the start of the Promotion Period.

(each, a "**Participant**" and collectively, the "**Participants**").

4. Eligible Participants will each receive 500 KrisFlyer miles ("**Bonus Miles**"), which will be credited into their KrisFlyer accounts within four (4) to six (6) weeks of the date of signing up.
5. Any KrisFlyer membership sign-ups received outside of the Promotion Period will not be considered for this Promotion, and will not be eligible to receive the Bonus Miles. Each Participant is only entitled to claim the Bonus Miles once in this Promotion.
6. The Bonus Miles will be valid for a period of three (3) years from the date on which it is credited into the Participant's KrisFlyer account, following which they shall expire and no extensions will be permitted.
7. This Promotion cannot be combined with any other campaigns or promotions, including other KrisFlyer membership sign up bonus promotions.
8. Each Participant is only permitted to hold one KrisFlyer membership account at any time, and any and all fraudulent or duplicate accounts, including the individual's original KrisFlyer membership account, will be suspended and disqualified from the Promotion. SIA reserves the right to exclude or disqualify any person from this Promotion and any future promotions on grounds of: (a) providing untrue, inaccurate or incorrect information; (b) misconduct or having acted or have had the intention to act in a dishonest or fraudulent manner or in bad faith; (c) tampering with the entry process or the operation of this Promotion; (d) acting in violation of the Terms and Conditions; (e) acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person; or (f) for any other reasons, as SIA may deem fit and proper. Any attempt to deliberately damage the SIA website or undermine the legitimate operation of the Promotion may be a violation of criminal and civil laws, and SIA reserves the right to seek damages and other remedies to the fullest extent permitted by law.

9. By entering into the Promotion, each Participant is confirming that he or she is eligible to do so and eligible to claim the Bonus Miles. SIA may require Participants to provide proof that he or she is eligible to enter the Promotion.

By participating in the Promotion, each Participant agrees to comply with and be bound by these Terms and Conditions, SIA's conditions of use of website (available at https://www.singaporeair.com/en_UK/sg/global_footer/conditions-of-use-website/), SIA's Privacy Policy, KrisFlyer Terms and Conditions, KrisShop Terms and Conditions, KrisFlyer vRooms Terms and Conditions, and Kris+ Terms and Conditions (as each of those terms are defined below) (collectively, "**SIA Terms & Conditions**"). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the participant being disqualified at any stage of the Promotion, and any Bonus Miles may be forfeited, withheld, withdrawn or reclaimed.

By participating in the Promotion, each participant agrees that any and all personal data he/she submits (including his/her name, date of birth, country of residence, KrisFlyer membership number, contact number and email address) may be collected, used, disclosed, or otherwise processed (collectively, "**Processed**") by SIA for the purposes of the Promotion. All collection, use and disclosure of participant's personal data will be in accordance with **SIA's Privacy Policy** (available online at http://www.singaporeair.com/en_UK/privacy-policy/).

The use of KrisFlyer miles to redeem an air ticket is subject to seat availability at the time of reservation or ticket issuance, and must be used in accordance with the terms and conditions of the KrisFlyer programme, (available online at https://www.singaporeair.com/en_UK/jp/ppsclub-krisflyer/termsconditions-kf/) ("**KrisFlyer Terms and Conditions**").
13. The use of KrisFlyer miles to redeem merchandise on <https://www.krisshop.com/en/> is subject to stock availability at the time of purchase and must be used in accordance with the terms and conditions of the KrisFlyer programme, and the terms of use of the KrisShop website (available online at <https://www.krisshop.com/en/page/platform-and-sale-terms>) ("**KrisShop Terms and Conditions**").
14. The use of KrisFlyer miles to redeem hotel stays or car rentals on KrisFlyer vRooms (available online at <https://www.krisflyervrooms.com/info/termsfuse.html>) is subject to room/car availability at the time of booking and must be used in accordance with the terms and conditions of the KrisFlyer programme, and the terms of use of the KrisFlyer vRooms website ("**KrisFlyer vRooms Terms and Conditions**").
15. The use of KrisFlyer miles to redeem for shopping, dining, wellness services via the Kris+ mobile application must be used in accordance with the terms and conditions of the KrisFlyer programme, and Kris+ partners (available online at https://www.singaporeair.com/en_UK/sg/ppsclub-krisflyer/use-miles/krisplus/terms-of-use) ("**Kris+ Terms and Conditions**").
16. All decisions made by SIA, in respect to any matter relating to this Promotion shall be final. SIA reserves the right to verify the eligibility of Participants, vary these Terms and Conditions without notice and/or liability to the Participants, terminate or otherwise amend this Promotion without prior notice at its sole and absolute discretion.
17. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss,

injury or disappointment) by entering the Promotion or the participant's acceptance of any Bonus Miles.

18. Unless otherwise specified, SIA is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of the Bonus Miles.

20. The Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.

SIA accepts no liability for any delay or failure to perform SIA's obligations in relation to this Promotion and under these Terms and Conditions if such a delay or failure is due to circumstances beyond SIA's reasonable control.

22. Trademarks

Trademarks used on the Site are a trademark or registered trademark of SIA. The participants must not use any of SIA's trademarks: (a) as part or all of the participants' own trademarks; (b) in connection with any business, products or services which are not SIA's; (c) in a manner which may be confusing, misleading or deceptive to any person; or (d) in a manner that disparages SIA, the materials, and/or the website.

23. General provisions

- (a) If SIA waives, in whole or part, any rights available to them under the SIA Terms & Conditions on one occasion, this does not mean that those rights will automatically be waived on any other occasion. If any provision of SIA Terms & Conditions is held to be invalid, unenforceable or illegal for any reason, it is to be read down to give it as much effect as possible, or if it is not capable of having any effect at all, it is to be severed from the SIA Terms & Conditions, in which case, the remainder of the SIA Terms & Conditions shall nevertheless continue in full force.
- (b) In the event of any inconsistency between these Terms and Conditions and any marketing or promotional materials relating to this Promotion, these Terms and Conditions shall prevail.
