

## Terms and Conditions of the Singapore Airlines – FORMULA 1 SINGAPORE AIRLINES SINGAPORE GRAND PRIX 2026 Gift Campaign

1. This F1 SINGAPORE AIRLINES SINGAPORE GRAND PRIX Lucky Draw Gift Campaign 2026 (“**Lucky Draw**”) is organized by Singapore Airlines Limited (Unique Entity Number: 197200078R), a company incorporated in Singapore and operating via its Japan regional office (“**SIA**”).
2. By participating in this Lucky Draw, participants are deemed to have accepted and agreed to be bound by these terms and conditions and any additional terms, amendments, or directives (“**Terms**”) which may be made or issued by SIA in its sole discretion either before or during the Lucky Draw.
3. This Lucky Draw, which involves voluntary participation, will be carried out on SIA Japan’s promotion page at [https://www.singaporeair.com/ja\\_JP/jp/plan-travel/local-promotions/f1\\_ticket\\_giveaway2026/](https://www.singaporeair.com/ja_JP/jp/plan-travel/local-promotions/f1_ticket_giveaway2026/) (“**Promotion Page**”) and will be open to participants (each a “**Participant**” and collectively, the “**Participants**”) who:
  - (a) are aged eighteen (18) years and above;
  - (b) reside in Japan; and
  - (c) have submitted a Qualifying Entry (as defined below) during the promotion period from 1 June 2026 00:00 (Japan Standard Time) to 31 July 2026 23:59 (Japan Standard Time) (“**Promotion Period**”). All Qualifying Entries (as defined in Clause 4) must be received by SIA during the Promotion Period, and any entries received after the end of the Promotion Period are automatically disqualified.
4. For an entry to qualify for this Lucky Draw (a “**Qualifying Entry**”), a Participant must satisfy all of the following:
  - (a) complete and submit the application form (available at the Promotion Page) with accurate, complete and truthful information, and correctly answer the quiz question in the application form;
  - (b) be a KrisFlyer member or Registered Customer (existing and new members/customers are eligible) during the Promotion Period.   - (d) be an individual (not a corporation or other artificial person) and not be:
    - i. an employee of SIA, Scoot, KrisShop, Kris+, or Pelago;
    - ii. an immediate family member of any person in (i); or
    - iii. (where applicable) an employee of SIA’s affiliates, subsidiaries, agencies, principal sponsors, or suppliers directly associated with this Lucky Draw.
5. To the extent permitted under applicable law, SIA will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind, busy lines, misspelt email addresses, acts of God etc. Additionally, SIA will not be responsible for: (a) any spam generated messages; (b) any SMS/whatsapp/other messaging service message delivery failures; (c) lost, misdirected, late, incomplete, or unintelligible entries or inaccurate entry information, whether caused by the Participant(s) or by any of the equipment or programming associated with or utilized in this Lucky Draw, or by any technical or human error that may occur in the processing of entries; (d) any printing

or typographical errors in any materials associated with this Lucky Draw; (e) any error in the operation or transmission, theft, destruction, loss, unauthorized access to, or alteration of, entries, or for technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any entry information on account of technical problems or traffic congestion on the website, internet or at any website; (f) injury or damage to the participant or any other computer or mobile resulting from downloading any materials in connection with this Lucky Draw; (g) if the Participants do not have mobile phones or other gadgets or means that support the Promotion Page/technical requirements; (h) if the Participant has registered himself/herself to the do-not-disturb (DND) of the telecom provider/Participant has specifically requested for not receiving messages for the specific promotion/campaign/contests; (i) other conditions beyond SIA's reasonable control or any force majeure event.

7. SIA reserves the right to substitute any Prize with another of equal or greater value at SIA's discretion. SIA will notify the Winners within two (2) weeks after the end of the Promotion Period or after the date of the Lucky Draw – whichever is later, via the email address provided by the Winners in the application form. SIA shall bear no responsibility for any invalid email address provided by any Participant. SIA reserves the right to verify the eligibility of the Participants. If no valid response is received from any Winner within five (5) working days from the date of the email sent by SIA, the Prize may be forfeited or another Winner may be chosen by SIA, in its sole discretion. SIA reserves the right to exclude or disqualify any person from the Lucky Draw on grounds of: (a) misconduct or criminal record or acted or have the intention to act in a dishonest or fraudulent manner or in bad faith; (b) tampering with the entry process or the operation of the Lucky Draw; (c) acting in violation of these Terms; (d) acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person; or (e) for any other reasons, as SIA may deem fit and proper.

SIA reserves the right to verify the eligibility of the Participants. In the event of a Participant's demise, their entry will be automatically disqualified.
14. Prizes are strictly non-negotiable, cannot be exchanged or redeemed for cash in part or in full. Prizes are not transferrable and cannot be sold. In the event it is sold or traded, the Prizes will be revoked.

16. The Terms shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
17. Force Majeure

SIA accepts no liability for any delay or failure to perform SIA's obligations in relation to this Lucky Draw and under these Terms if such a delay or failure is due to circumstances beyond SIA's reasonable control.

18. Trademarks

- (a) The participants must not use any of SIA's name, logo or trademark without SIA's prior written consent. When such consent is granted, the participants shall not use any of the SIA's trademarks: (a) as part or all of the participants' own trademarks; (b) in connection with any business, products or services which are not SIA's; (c) in a manner which may be confusing, misleading or deceptive to any person; or (d) in a manner that disparages SIA, the materials, and/or the website.

- (c) SIA shall retain sole and exclusive ownership of all of its intellectual property and nothing in these Terms shall be construed in any way to transfer or assign any such ownership to any participants.

19. General provisions

- (a) The Participants must not release to the public any news release, advertising material, promotional material or any other form of publicity relating to the Lucky Draw without prior written permission from SIA.
- (b) No failure or delay by SIA to exercise any right, power or remedy shall operate as a waiver of it nor shall any partial exercise preclude any further exercise of any right, power or remedy, or of some other right, power or remedy
- (c) In the event that any term or condition of these Terms is determined by a court or adjudicator of competent jurisdiction to be invalid, or unenforceable, such invalid or unenforceable terms or condition shall be deemed to be deleted from these Terms and the remainder of these Terms will remain in full force and effect.
- (d) A person who is not a party to these Terms has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Terms.
- (e) In the event of any inconsistency between the Terms and any marketing or promotional materials relating to this Lucky Draw, these Terms shall prevail.
- (f) Formula One World Championship Limited and its related companies ("F1") and the Event Organiser each are not responsible for or involved in the organisation, development, execution or results of this promotion. This promotion is organised exclusively by Singapore Airlines.
