

## TERMS & CONDITIONS FOR "ENROLL AND FLY" CAMPAIGN

1. These Terms and Conditions govern the "**Enroll and Fly**" Campaign (the "Promotion") organized by Singapore Airlines ("SIA").
2. The Promotion is applicable only to new KrisFlyer members who are domiciled in the **United States of America** (the "Participants") who have enrolled into the KrisFlyer program using the promo code "KFUSEAF" and carried out an Eligible Transaction (as defined below) during the promotional period of **29 October 2025 and 26 November 2025** (the "Promotional Period").
3. An "Eligible Transaction" refers to the purchase and usage of air tickets from SIA that satisfies the following criteria:
  - a. The tickets are purchased during the Promotional Period from <http://www.singaporeair.com>;
  - b. The date of travel on the tickets falls between **29 October 2025 and 31 March 2026**, inclusive; and
  - c. Travel must be completed by **31 March 2026**.
  - d. Travel blackout period is from **10 December 2025 to 10 January 2026**.
4. Participants who have carried out an Eligible Transaction shall be entitled to an additional bonus of **50% KrisFlyer miles** for bookings in booking classes Z/C/J/U/D/S/T/P/L/R/Y/B/E/M/H/W/Q/N/K/V, in addition to the KrisFlyer miles earned in respect of the Eligible Transaction based on SIA's standard terms and fare conditions ("Bonus Miles").
5. **Bonus Miles Award and Eligibility:**
  - a. Bonus Miles are calculated based on the total number of KrisFlyer miles earned from the combination of distance flown and applicable cabin bonuses.
  - b. Where tickets are partially paid using miles (e.g., "Miles + Pay"), Bonus Miles shall be applicable only to the portion of the ticket paid for in cash or with credit card.
  - c. Bonus Miles earned through this Promotion are not eligible for tier qualification.
  - d. Bonus Miles will only be credited into the Participant's KrisFlyer membership account once all travel has been completed in accordance with these Terms and Conditions.

6. Bonus Miles awarded through this Promotion will be valid for a period of **three (3) years** from the date on which they are credited into the Participant's KrisFlyer membership account, following which they shall expire without additional notice to the Participant. No extensions will be permitted for Bonus Miles.
7. This Promotion cannot be combined with any other campaigns or promotions, unless otherwise explicitly stated by SIA.
8. Each individual may only enroll into the KrisFlyer program once. Should any individual be discovered to have fraudulent or duplicate KrisFlyer membership accounts, such accounts (including the individual's original KrisFlyer account) shall be suspended and disqualified from participating in the Promotion and any miles awarded under the Promotion will be revoked without compensation or prior notice to the Participant.
9. By participating in the Promotion, each Participant agrees to the following:
  - a. to comply with and be bound by these Terms and Conditions, as well as KrisFlyer program rules and SIA's general Conditions of Carriage and Privacy Policy (collectively referred to as "SIA Terms & Conditions");
  - b. that any personal data collected for the purposes of the Promotion (including but not limited to KrisFlyer membership numbers, full names, and travel details) may be collected, used, disclosed, and otherwise processed by SIA for the purpose of administering the Promotion; and
  - c. that all personal data collection and processing will be carried out in strict compliance with SIA's Privacy Policy, available at <https://www.singaporeair.com/privacy-policy/>.
10. SIA reserves the sole discretion to verify the eligibility of Participants and to determine whether any transaction meets the criteria of an "Eligible Transaction."
11. SIA reserves the right to, at its sole discretion, amend, vary, or modify these Terms and Conditions and/or to terminate this Promotion without prior notice or liability. Any decisions made by SIA in connection with all matters relating to this Promotion are final and no correspondence will be entertained.
12. To the extent permitted by applicable laws, SIA shall not be liable for any losses, damages, costs, or expenses incurred by Participants in connection with this Promotion, including (but not limited to) any delays, travel disruptions, financial losses, or inability to complete a transaction due to technical issues.

13. In the event of any inconsistency between these Terms and Conditions and any marketing or promotional materials associated with the Promotion, these Terms and Conditions shall prevail.
14. Unless otherwise specified, SIA is not responsible for and will not cover any additional travel costs, fees, or incidental expenses incurred by the Participant when fulfilling the Eligible Transaction.
15. Bonus Miles cannot be exchanged or redeemed for cash, and are not transferable.
16. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act or similar legislation to enforce any of these Terms and Conditions.
17. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts. To the extent any of these Terms and Conditions may be contrary to the laws of the United States of America, such term shall be void.
