

1. "Where Privilege Takes Flight" Spending Rewards Terms and Conditions

1. The promotion period is from 27 July to 31 August 2026.
2. Shoppers are required to register as both ELEMENTS CLUB and KrisFlyer members to join this promotion. Shoppers can register as ELEMENTS CLUB members via ELEMENTS APP, and as KrisFlyer members via singaporeair.com/kfsignup.
