

## KrisFlyer mileage accrual levels on Singapore Airlines and Partner airlines

For codeshare flights operated by our partner airlines, mileage accrual eligibility and levels are awarded based on the operating airline's booking class, which may differ from the booking class letter reflected on your flight ticket. Please contact [Singapore Airlines](#) to determine if your ticketed flight is eligible for KrisFlyer mileage accrual.
