## **TERMS AND CONDITIONS FOR**

## **KRIS+ SCRATCH & WIN PROMOTION**

These terms and conditions govern the Kris+ SCRATCH & WIN promotion (the "**Promotion**") organised by Singapore Airlines Limited ("**SIA**").

- 1. The Promotion is open to all KrisFlyer members residing in Singapore who have performed a Kris+ Transfer Transaction during the Promotional Period (as defined in paragraph 2 below) ("Participant"). For the purposes of these Terms and Conditions, a "Kris+ Transfer Transaction" refers to a transfer of a minimum of 450 KrisPay miles to the Participant's Kris+ account using either the Participant's (i) KrisFlyer miles, (ii) DBS Points, (iii) UOB UNI\$ (a minimum of 1,000 UNI\$ is required for each transfer transaction), or (iv) CapitaStar STAR\$®, regardless of the type of mobile device from which such redemption transaction is performed. Each Kris+ Transfer Transaction made during the Promotional Period entitles each Participant to one (1) chance to participate in the Promotion, regardless of the total number of KrisPay miles eventually transferred by the Participant to his/her own Kris+ account.

The Promotion commences in the following weekends 26 Jun 2021, 0000 hrs (Singapore time) to 27 Jun 2021, 2359 hrs (Singapore time), 3 Jul 2021, 0000 hrs (Singapore time) to 4 Jul 2021, 2359 hrs (Singapore time) and 10 Jul 2021, 0000 hrs (Singapore time) to 11 Jul 2021, 2359 hrs (Singapore time) ("Promotional Periods").
- 3. After successfully performing a Kris+ Transfer Transaction, eligible Participants will be entitled to one (1) chance to participate in the Kris+ SCRATCH & WIN (the "Game"). A virtual scratch card will appear on the App following the successful Kris+ Transfer Transaction, and Participants may then brush on the grey virtual scratch card square on the screen to reveal a prize as further detailed in paragraph 4 below ("the Prize). Participants have to click on the "claim miles" button on the App for the Prize to be instantly credited into each Participant's respective Kris+ accounts. The Prize will be valid for a period of 6 months from the date of credit, following which it will expire and no extensions will be permitted.
- 4. The value of each Prize that may be awarded to eligible Participants for each Kris+ Transfer Transaction will be in accordance with the following table:

- 5. Any Prizes won in this Promotion in the form of KrisPay miles credited into each Participant's Kris+ account can only be used within the App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other Kris+ accounts, and cannot be exchanged for cash.
- 6. By participating in the Promotion, each Participant:
  - a. agrees to comply with and be bound by these terms and conditions, SIA's conditions of use of website, SIA's Privacy Policy, and the Kris+ Terms and Conditions (collectively, "SIA Terms & Conditions")). Non-compliance with or breach of any of these SIA Terms and Conditions may

- result in the participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed; and
- b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, "Processed") by SIA for the purposes of organizing the Promotion and issuing the Prizes. All collection, use and disclosure of each Participant's personal data will be in accordance with SIA's Privacy Policy (available online at http://www.singaporeair.com/en\_UK/privacy-policy/).
- 7. All decisions made by SIA in respect to any matter relating to this Promotion shall be final. SIA reserves the right to vary these terms and conditions, or terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
