

**TERMS AND CONDITIONS FOR
KRIS+ FEBRUARY REWARDS ACCELERATOR CAMPAIGN**

1. These terms and conditions govern the Kris+ February Rewards Accelerator Campaign (the “**Promotion**”) organised by Kris+ Pte. Ltd. (“Kris+”). This campaign will be carried out on the Kris+ mobile application (“**Kris+ App**”).
2. The Promotion is applicable to all KrisFlyer members (“**Participants**”) who:
 - a. have downloaded the Kris+ Mobile Application (“**Kris+ App**”); and
 - b. have completed the Promotion’s enrolment condition as defined in clause 3 below; and
 - c. have carried out an “**Eligible Payment Transaction**” (as defined in clause 5 below) during the promotional period from 14 February 2025, 1000hrs (SGT) to 28 February 2025, 2359hrs (SGT) (the “**Promotional Period**”).

For avoidance of doubt, participants who do not satisfy any of the conditions above will not be eligible to enter the Promotion and will be disqualified despite having completed an Eligible Transaction.

3. To enrol in the Promotion, users (“Participants”) must access the “February Rewards Accelerator” challenge under the Kris+ challenge page and tap “Start now”.
4. For avoidance of doubt, enrolment to the Promotion signifies interest to participate, and all Eligible Payment Transactions (as defined in clause 5 below) made by Participants during the Promotional Period will be considered.
5. Subsequent to being enrolled in the Promotion, a Participant can proceed to make an “**Eligible Payment Transaction**” using any form of payment methods, directly through the Kris+ App at any Participating Kris+ Partner, with no minimum or maximum limit to the amount of eligible transaction a Participant is required to make. An Eligible Kris+ Payment Transaction refers to transactions made at Participating Kris+ Partners (as defined in clause 6) using the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Kris+ Payment Transaction is performed, so long as they are carried out within the Promotional Period and made subsequent to Promotion enrolment.
6. **Participating Kris+ Partners** include all merchants that accept payments through the Kris+ app via Apple Pay (for iOS devices) or Google Pay (for Android devices) in Singapore.
7. The Promotion offers two reward tiers based on a Participant’s Qualifying Spend during Promotional Period, illustrated in the table below. “**Qualifying Spend**” is calculated based on the Participant’s total Eligible Payment Transactions within the Promotional Period. For avoidance of doubt, Eligible Payment Transactions that have been refunded before the date of reward will not be considered towards Qualifying Spend.

Reward Tiers	Qualifying Spend	Reward Cap	Reward
1	S\$200 to S\$499.99	First 1,000 users	500 bonus miles
2	S\$500 and above	First 500 users	1,500 bonus miles

8. A Participant is eligible for only one reward tier. For example, if a Participant's Qualifying Spend is \$1,000, the Participant will only be eligible for Tier 2's rewards (as defined in clause 7).
9. For avoidance of doubt, the 500 users to be rewarded under Tier 2 will be identified as the users who first meet Tier 2's Qualifying Spend after enrolling into the Promotion, and not the users who first enroll in the Promotion, even if they eventually meet the Qualifying Spend. Likewise, the first 1,000 users to be rewarded under Tier 1 will then be identified as the users who first meet Tier 1's Qualifying Spend after enrolling into the Promotion, and not the users who first enroll in the Promotion, even if they eventually meet the Qualifying Spend
10. The bonus miles will be credited to the Participant's Kris+ app by 14 March 2025.
11. The Bonus Miles in KrisPay miles shall be credited into the Winners' Kris+ accounts. The validity, transfer and use of KrisPay miles credited into the Winners' accounts shall be subject at all times to the Terms of Use of Kris+ (accessible at https://www.singaporeair.com/en_UK/sg/ppsclub-krisflyer/use-miles/krisplus/terms-of-use/). The Prizes in KrisPay miles may be converted into KrisFlyer miles but such conversion must be done: (a) for the entirety of the Prize (i.e. a Winner may not convert and transfer only part of his or her Prize into KrisFlyer miles), and (b) within 21 days from the time that the Prize is credited into the Winner's Kris+ account.
12. By participating in the Promotion, each Participant:
 - a. agrees to comply with and be bound by these Terms and Conditions, Kris+ Privacy Policy (accessible at https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppsclub-krisflyer/use-miles/krisplus/Privacy_Policy.pdf), the KrisFlyer Terms and Conditions (https://www.singaporeair.com/en_UK/ppsclub_krisflyer/termsconditions-kf/), and the Terms of Use of Kris+ (accessible at https://www.singaporeair.com/en_UK/sg/ppsclub-krisflyer/use-miles/krisplus/terms-of-use/) (collectively, "Promotional Terms & Conditions"); and
 - b. agrees that any and all personal data collected in this Promotion (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, "Processing") by Kris+ for the purposes of organizing the Promotion. All Processing of each Participant's personal data will be in accordance with Kris+'s Privacy Policy available at https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppsclub-krisflyer/use-miles/krisplus/Privacy_Policy.pdf).
13. Kris+ reserves the right to vary these terms and conditions, amend the list of Participating Kris+ Partners in which Eligible In-App Payment Transactions may be made, and terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
14. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.

15. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant's acceptance of any prize.
16. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of the Award.
17. These terms and conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
