

## TERMS AND CONDITIONS FOR 25% DEALS MILES-BACK PROMOTION

These terms and conditions (“**Terms and Conditions**”) govern the 25% miles-back deals promotion (the “**Promotion**”) organised by Kris+ Pte Ltd (“**Kris+**”). This Promotion will be carried out on the Kris+ mobile application (“**Kris+ App**”).

1. The Promotion is applicable to all KrisFlyer members (“**Participants**”) who have complete the eligible Kris+ challenge and carried out an Eligible Kris+ Redemption Transaction (as defined in clause 2 below) during the promotional period from 02 July 2025, 1000 hrs (SGT) and ends on 15 July 2025, 2359 hrs (SGT) (the “**Promotional Period**”).
2. To enroll and be eligible for the Promotion, Participants need to access the “Deals Miles-Back” challenge under the Kris+ challenges page and tap “Start now”. Transactions made before Participants start the challenge will not be eligible.
3. For the purposes of these Terms and Conditions, an “**Eligible Kris+ Redemption Transaction**” refers to any transaction made entirely with KrisPay miles through the Kris+ App for selected Kris+ deals during the Promotional Period. All Eligible Kris+ Redemption Transactions must be completed via the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Kris+ Redemption Transactions are performed, as long as they are carried out within the Promotional Period and have started the “Deals Miles-Back” challenge.
4. Participants will be eligible to receive a 25% rebate of KrisPay miles for each Eligible Kris+ Redemption Transaction. The rebate amount is calculated based on the total KrisPay miles redeemed in the transaction, as demonstrated in the example below:

<b>KrisPay miles used to purchase selected deals at selling price as at 2 July 2025</b>	<b>25% Miles-Back</b>
Joy's Teahouse box of 4 egg tarts requires 820 KrisPay miles	The Participant will receive 25% of their spent KrisPay miles (205 KrisPay miles) as a rebate, rounded down to the nearest whole number.

5. The 25% KrisPay miles back for all Eligible Kris+ Redemption Transactions will be credited into the Participant’s Kris+ account within 14 days after the Promotional Period. Such KrisPay miles are non-transferrable and shall be valid for 6 months from the date of credit.
6. KrisPay miles credited into an applicable Participant’s KrisPay account can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other Kris+ accounts and cannot be exchanged or redeemed for cash.
7. By participating in the Promotion, each Participant:
  - a. agrees to comply with and be bound by these Terms and Conditions, Kris+’s Terms of Use, Kris+’s Privacy Policy, KrisFlyer Terms and Conditions, and the Kris+ Terms and Conditions (collectively, “**Kris+ Terms & Conditions**”). Non-compliance with or breach of any of these Kris+ Terms and Conditions may result in the Participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed and

- b. agrees that any and all personal data collected in this Promotion (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, **"Processed"**) by Kris+ for the purposes of organizing the Promotion. All collection, use and disclosure of each Participant's personal data will be in accordance with Kris+'s Privacy Policy available at [https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppclub-krisflyer/use-miles/krisplus/Privacy\\_Policy.pdf](https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppclub-krisflyer/use-miles/krisplus/Privacy_Policy.pdf)).
8. All decisions made by Kris+, in respect to any matter relating to this Promotion shall be final. Kris+ reserves the right to vary these Terms and Conditions and/or the Kris+ Terms & Conditions at any time, amend the list of Kris+ Partners in which eligible Kris+ Redemption Transactions may be made, terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
9. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
10. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant's acceptance of any prize
11. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of any Prize.
12. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
13. A person who is not a party to these Promotion Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Promotion Terms and Conditions.
14. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
