

**TERMS AND CONDITIONS FOR
KRIS+ TIERED BONUS MILES PROMOTION**

These terms and conditions (“**Terms and Conditions**”) govern the Kris+ Tiered Bonus Miles Promotion (the “**Promotion**”) organised by Kris+ Pte. Ltd. (“**Kris+**”). This Promotion will be carried out on the Kris+ mobile application (“**Kris+ App**”).

1. The Promotion commences on 9 September 2025 10:00hrs (Singapore time) and ends on 30 September 2025 23:59hrs (Singapore time) (“**Promotional Period**”).
2. The Promotion applies to all KrisFlyer members who have successfully completed a Kris+ Transfer Transaction during the Promotion Period (“**Participant**”):
 - a. For purposes of these Terms and Conditions, a “**Kris+ Transfer Transaction**” refers to a transaction by a Participant that effects a transfer of a minimum of 10 KrisFlyer miles from their KrisFlyer account into such Participant’s Kris+ account, through the Kris+ app, regardless of the type of mobile device from which such transaction is performed.
3. Participants who successfully carry out a Kris+ Transfer Transaction within the Promotional Period, will be entitled to receive bonus KrisPay miles (“**Bonus Miles**”), which will be credited directly into the Participant’s Kris+ account instantly. The quantum of the Bonus Miles will be based on a tiered structure according to the actual number of KrisFlyer miles transferred to Kris+ as part of the qualifying Kris+ Transfer Transaction, rounded to the nearest whole number.
 - a. The tiered structure is as follows:

No. of miles transferred from KrisFlyer to Kris+	Percentage of Bonus Miles awarded
Between and inclusive of 10 to 5,999	20%
Between and inclusive of 6,000 to 99,999	25%
Inclusive of and above 100,000	30%

- b. An illustration is as follows:

No. of miles transferred from KrisFlyer to Kris+	No. of resultant KrisPay miles in Kris+ (Without Promotion)	No. of resultant KrisPay miles in Kris+ (With Promotion)

4. The Bonus Miles shall be valid for 6 months from the date of credit, can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. The Bonus Miles are also non-transferable to other Kris+ accounts and cannot be exchanged or redeemed for cash.
5. By participating in the Promotion, each Participant:
 - a. agrees to comply with and be bound by these Terms and Conditions, the Kris+ Privacy Policy (accessible at https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppsclub-krisflyer/use-miles/krisplus/Privacy_Policy.pdf), the KrisFlyer Terms and Conditions (accessible at https://www.singaporeair.com/en_UK/ppsclub_krisflyer/termsconditions-kf/) and the Terms of Use of Kris+ (accessible at https://www.singaporeair.com/en_UK/sg/ppsclub-krisflyer/use-miles/krisplus/terms-of-use/); and
 - b. agrees that any and all personal data collected in this Promotion (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, “**Processing**”) by Kris+ for the purposes of organizing the Promotion. All Processing of each Participant’s personal data will be in accordance with the Kris+ Privacy Policy (accessible at https://www.singaporeair.com/content/dam/sia/web-assets/pdfs/ppsclub-krisflyer/use-miles/krisplus/Privacy_Policy.pdf).
6. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
7. Kris+ reserves the right to place any and all accounts suspected of abuse or unusual activity on hold. Where abuse or suspicious activity is identified by Kris+, Kris+ reserves the right to withdraw any and all bonus miles awarded during the Promotion.
8. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant’s acceptance of any Bonus Miles.
9. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of the Bonus Miles.
10. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
