

## TERMS AND CONDITIONS FOR KRIS+ TOP-UP & WIN CAMPAIGN

1. The Terms and Conditions herein relate to the Kris+ Top-Up & Win Campaign (collectively, the “**Promotion**”), which is organised by Singapore Airlines Limited (“**SIA**”).
2. The Promotion commences on 21 December 2022, 0000 hrs (Singapore time) and ends on 31 December 2022, 2359 hrs (Singapore time) (“**Promotion Period**”).
3. The Promotion is only open to all KrisFlyer members residing in Singapore who have successfully completed a **Kris+ Transfer Transaction** during the Promotion Period (“**Participant**”).
  - a. For the purposes of these Terms and Conditions, a “**Kris+ Transfer Transaction**” refers to a transaction by a Participant to effect a transfer of a minimum of 750 KrisPay miles into such Participant’s KrisPay wallet, using either the Participant’s (i) KrisFlyer miles, (ii) DBS Points (in blocks of 100 DBS points), (iii) UOB UNI\$ (a minimum of 1,000 UNI\$ is required for each Kris+ Transfer Transaction), (iv) CapitaStar STAR\$®, or (v) Citi ThankYou Rewards (a minimum of 10,000 Citi Points or 4,000 Citi Miles is required for each Kris+ Transfer Transaction) through the Kris+ mobile application (the “**App**”), regardless of the type of mobile device from which such transfer transaction is performed
4. Each Kris+ Transfer Transaction made during the Promotion Period entitles each Participant to one (1) chance to participate in the Promotion, regardless of the total number of KrisPay miles eventually transferred by the Participant to their own KrisPay wallet.
5. After successfully completing a Kris+ Transfer Transaction, eligible Participants will be entitled to one (1) chance to participate in the Kris+ Scratch & Win (the “**Game**”). A virtual scratch card will appear on the App following the successful Kris+ Transfer Transaction, and Participants may then brush on the grey virtual scratch card square on the screen to reveal a prize as further detailed in paragraph 6 below (“the Prize”). Participants have to tap on the “claim miles” button on the App for the Prize to be instantly credited into each Participant’s respective Kris+ accounts. The Prize will be valid for a period of 6 months from the date of credit, following which it will expire and no extensions will be permitted.
6. The value of each Prize that may be awarded to eligible Participants for each Kris+ Transfer Transaction will be in accordance with the following table:

7. All KrisPay miles distributed in this Promotion will be credited into the Participant’s KrisPay wallet can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other KrisPay wallets, and cannot be exchanged for cash.

8. All KrisPay miles awarded in this Promotion are valid for a period of six (6) months from the date in which they are credited into the Participant's KrisPay wallet, following which they shall expire and no extensions will be permitted.
9. By participating in the Promotion, each Participant:
  - a. agrees to comply with and be bound by these Terms and Conditions, SIA's conditions of use of website, SIA's Privacy Policy, and the Kris+ Terms and Conditions (collectively, "**SIA Terms & Conditions**"). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed; and
  - b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number, full name and mailing address) may be collected, used, disclosed, or otherwise processed (collectively, "**Processed**") by SIA for the purposes of organizing the Promotion and issuing the Prizes. All collection, use and disclosure of each Participant's personal data will be in accordance with SIA's Privacy Policy (available online at [http://www.singaporeair.com/en\\_UK/privacy-policy/](http://www.singaporeair.com/en_UK/privacy-policy/)).
10. Non-compliance with or breach of these SIA Terms & Conditions may result in the Participant being disqualified at any stage of the Promotion, and any Prizes won may be forfeited, withheld, withdrawn or reclaimed.
11. All decisions made by SIA, in respect of all matters relating to the Promotion, including the choice of the Winner(s) shall be final. SIA reserves the right to vary these Terms and Conditions, or terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
12. SIA reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
13. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion, playing the Game, or the participant's acceptance of any prize.
14. Unless otherwise specified, SIA is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of any Prize.
15. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
