

TERMS AND CONDITIONS FOR KRIS+ FOOD TRAIL PROMOTION

These terms and conditions govern the Kris+ Food Trail (a) 5X Earn Promotion (b) Food Trail Bonus Miles promotion (collectively, the “**Promotion**”) organised by Singapore Airlines Limited (“**SIA**”).

1. The Promotion is applicable to all KrisFlyer members (“Participants”) who have downloaded Kris+ Mobile Application (“Kris+ App”) and have carried out Eligible Kris+ Transactions at Participating Kris+ Partners from 8 January 2021, 1000 hrs (Singapore time) and ends on 31 January 2021, 2359 hrs (Singapore time) (“**Promotional Period**”).
2. A “Participating Kris+ Partner” refers to any Kris+ partner in the table set out in this Clause below,

5X Earn Promotion

3. Participants who have carried out any Earn Transaction will receive 5 times the amount of KrisPay miles for every SGD 1 spent at any Earn Bonus Partner during the Promotional Period (“Earn Bonus Award”). Instead of 2 KrisPay miles per SGD 1 spent, participants will receive 10 KrisPay miles per SGD 1 spent during the Promotional Period.
4. The Earn Bonus Award will be awarded to Participants immediately via the Kris+ App, and are transferrable only in their entirety to the Participant’s KrisFlyer account via the Kris+ App within seven (7) days from the date the Earn Bonus Award was granted to the relevant Participant.
5. For the avoidance of doubt, no partial transfers of the Earn Bonus Award will be permitted, and no KrisPay miles awarded to any Participant under the Earn Bonus Award may be transferred to that same Participant’s KrisFlyer account after the end of the foregoing seven (7) day period.

Food Trail Bonus Miles Promotion

6. 2,000 KrisPay miles (“**Food Trail Bonus Miles**”) will also be awarded to each person who successfully dines at least one (1) time each at all three (3) **participating partner restaurant**. A total of 3 **Eligible Transactions** (once at each participating partner restaurant) must be completed for “Food Trail Bonus Miles” to be awarded.
7. Each Participant can win a maximum of 1 “Food Trail Bonus Miles”. Any Kris+ transaction made after each Participant’s first three (3) Eligible Kris+ Transactions or any Kris+

transactions that occurs outside the Promotional Period would not be deemed to be Eligible Kris+ Transactions in accordance with the Promotion.

8. For the purposes of these terms and conditions, an “Eligible Transaction” refers to any of the following transactions made by Participants during the Promotional Period at the Participating Kris+ Partners using either cash, credit/debit card, or payment via the Kris+ App:
 - a. Cash / Credit Card Earn Transaction: Any payment of a minimum amount of SGD \$1 made via cash, debit or credit card to any Participating Partner Restaurants listed above (“Earn Transaction”).
 - b. Miles Redemption Transaction: Any single transfer of at least 15 KrisPay miles (SGD \$0.10) to any Participating Partner Restaurants listed above (“Redemption Transaction”).

All Eligible Transactions must be completed using the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Transactions are performed, as long as they are carried out within each Promotional Period.

9. At the end of the Promotional Period, the “Food Trail Bonus Miles” will be credited into each Participant’s KrisPay account within ten (10) working days. The Prize(s) cannot be exchanged or redeemed for cash, and shall not be transferred to another individual.
10. KrisPay miles awarded for Eligible KrisPay Transactions can only be used within the KrisPay App and cannot be transferred into any KrisFlyer account. Such KrisPay miles are also non-transferable to other KrisPay accounts, and cannot be exchanged for cash.
