

## TERMS AND CONDITIONS

1. This KrisFlyer Spree 6<sup>th</sup> Anniversary promotion ("**Promotion**") is organized by Singapore Airlines Limited ("**SIA**").
2. This Promotion will be carried out on krisflyerspree.com (the "**Platform**") and entry is open to all KrisFlyer members ("**Members**"). The Promotion commences on 20 July 2020 00:00, [GMT+8] and ends on 19 August 2020 23:59, GMT+8 ("**Promotion Period**").
3. To participate in the Promotion, Members must carry out transactions which are tracked and approved on the Platform ("**Approved Transactions**") from any of the thirty (30) participating brands listed at [www.krisflyerspree.com/campaign](http://www.krisflyerspree.com/campaign) ("**Partners**"), only in respect of each Partner's specific market(s) which are listed on the Platform as a participating market in the Promotion, in order to earn 2x KrisFlyer miles (i.e. a 100% bonus for each KF mile earned) for each transaction made on the Platform during the Promotion Period ("**Bonus Miles**").
4. The top ten (10) Members who earn the highest number of total KrisFlyer Miles during the Promotion Period ("the **Winners**") will earn an additional 6,000 KrisFlyer miles ("**Prize**") each.
  - Approved Transactions must be approved and validated by the merchants from whom a purchase is made within 120 days after the end of the Promotion Period in order to be eligible for the Prize.
  - The Prize will be awarded by 31 December 2020.
5. Transactions made at all other merchants listed on the Platform aside from the Partners defined in paragraph 3 above will be subject to the regular KrisFlyer miles earning rate specified on the Platform at the time of transaction, and will be calculated based on Approved Transactions.
