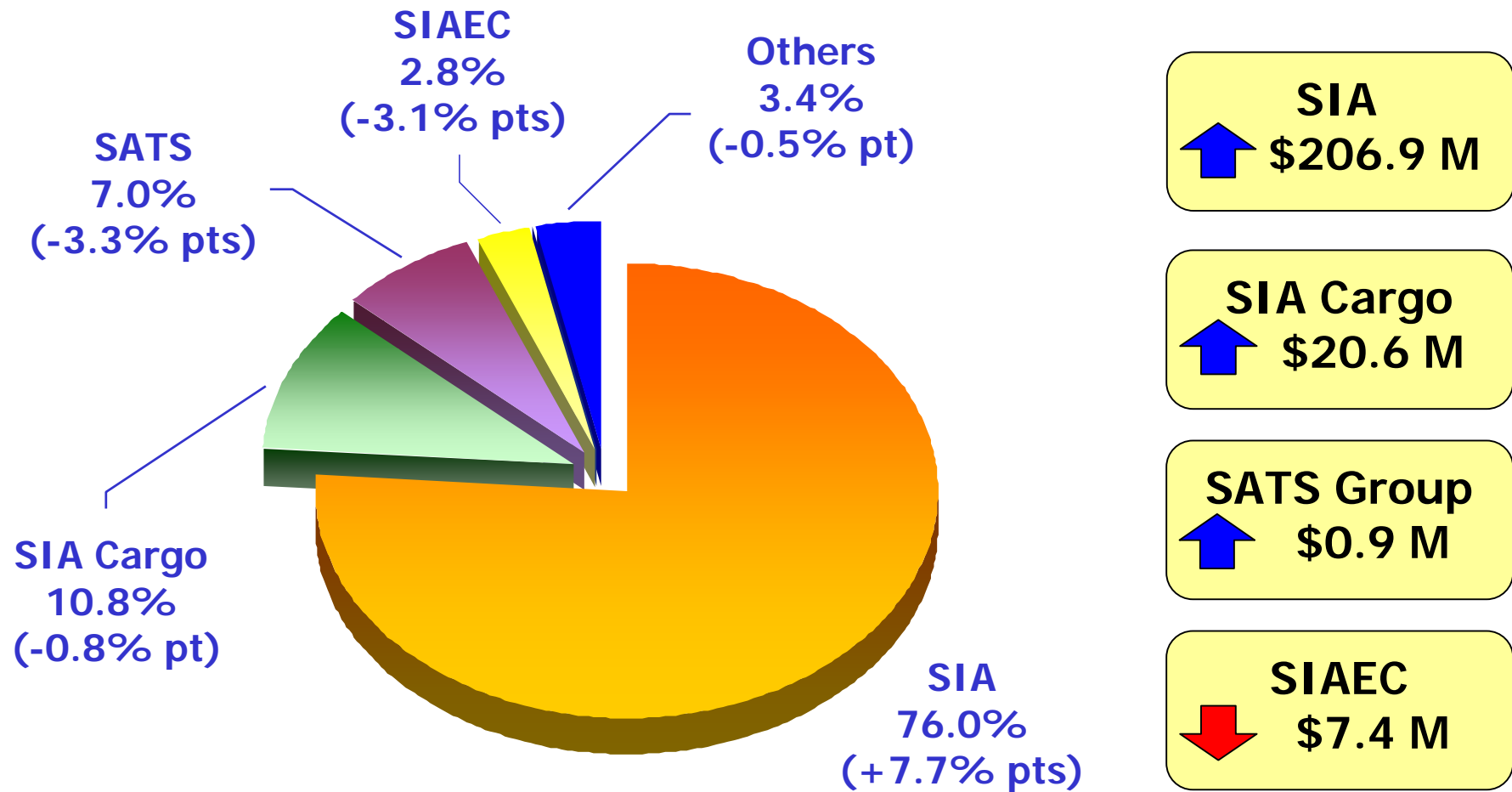

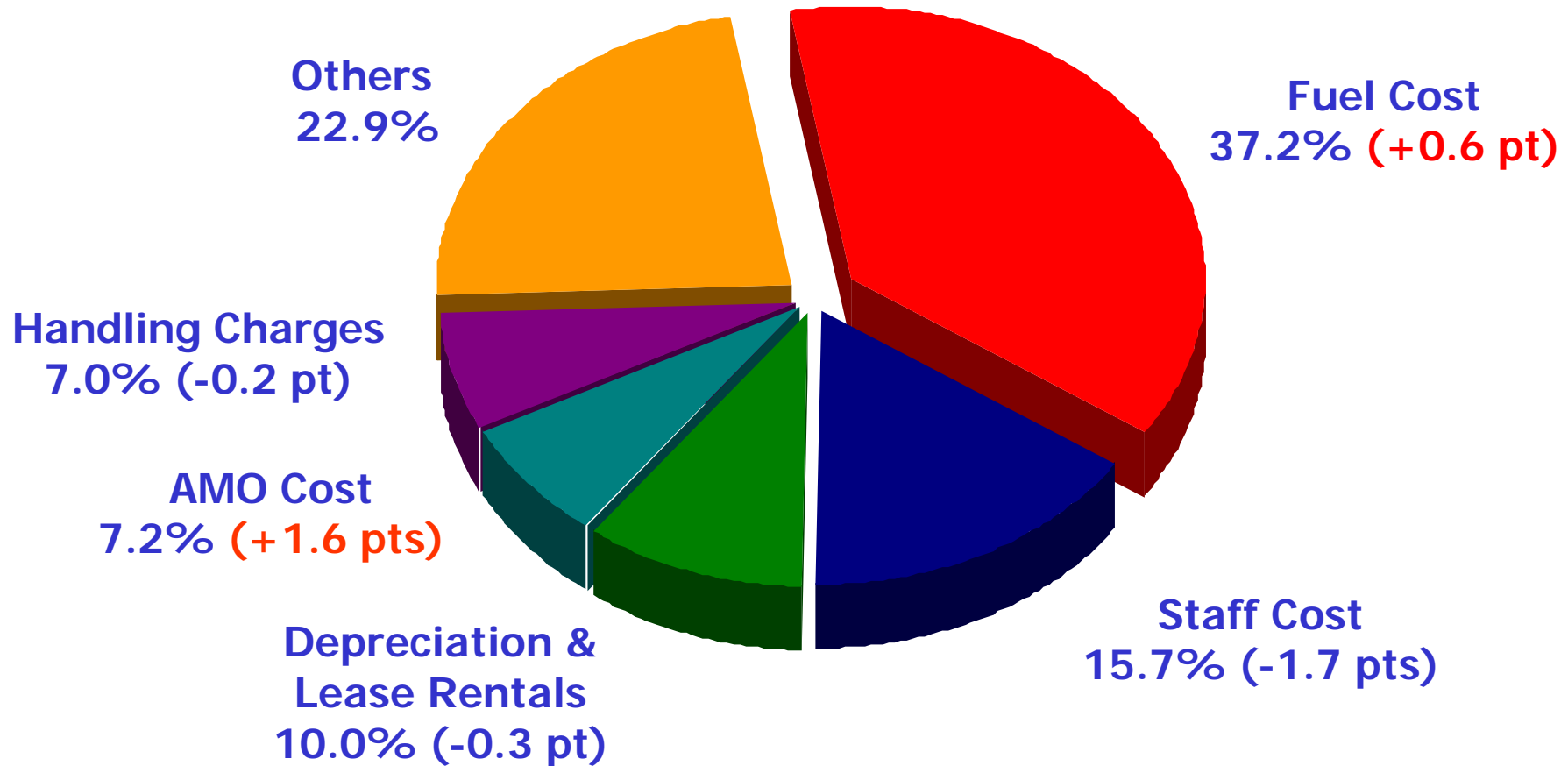

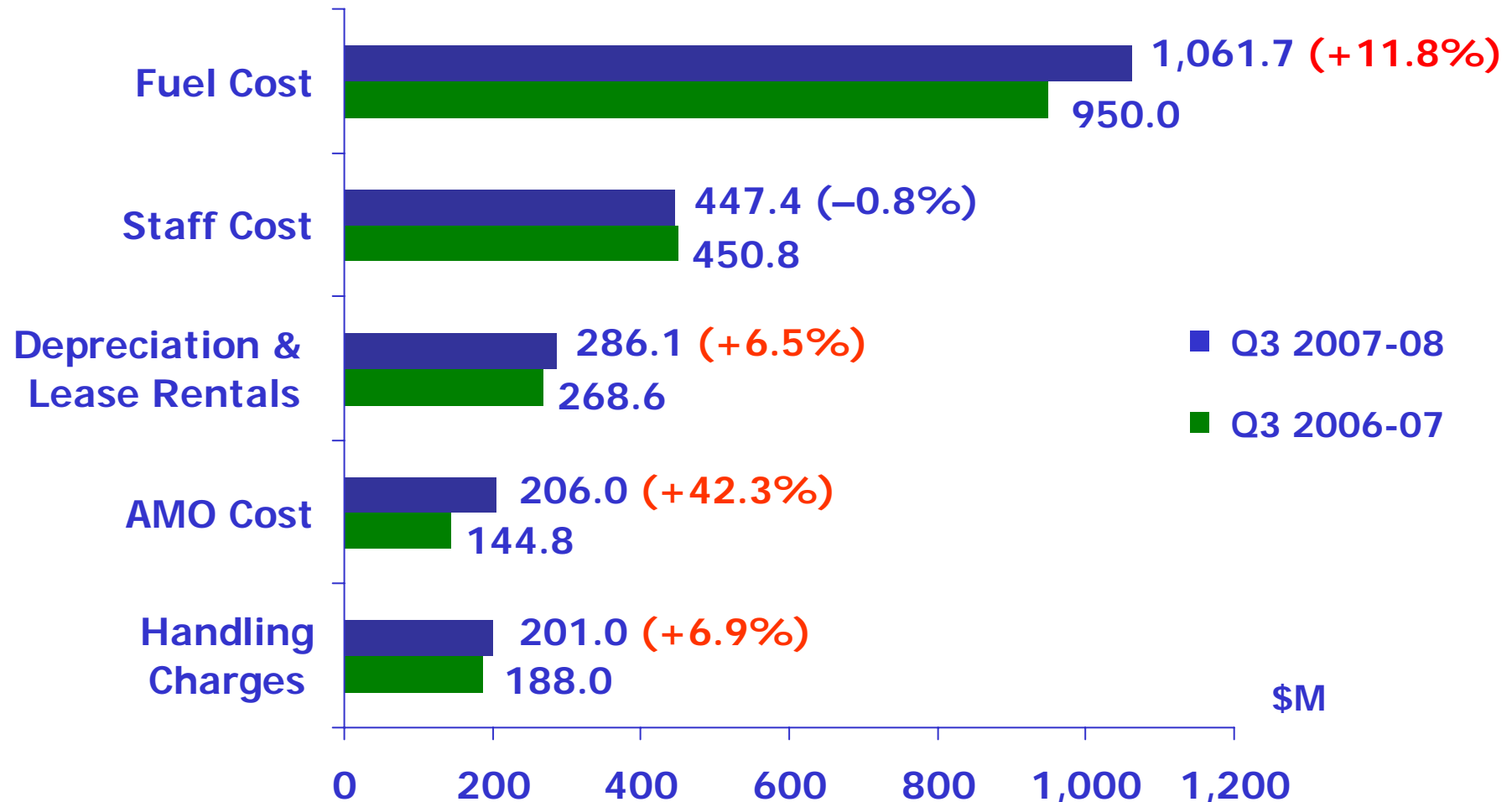

Cost Composition



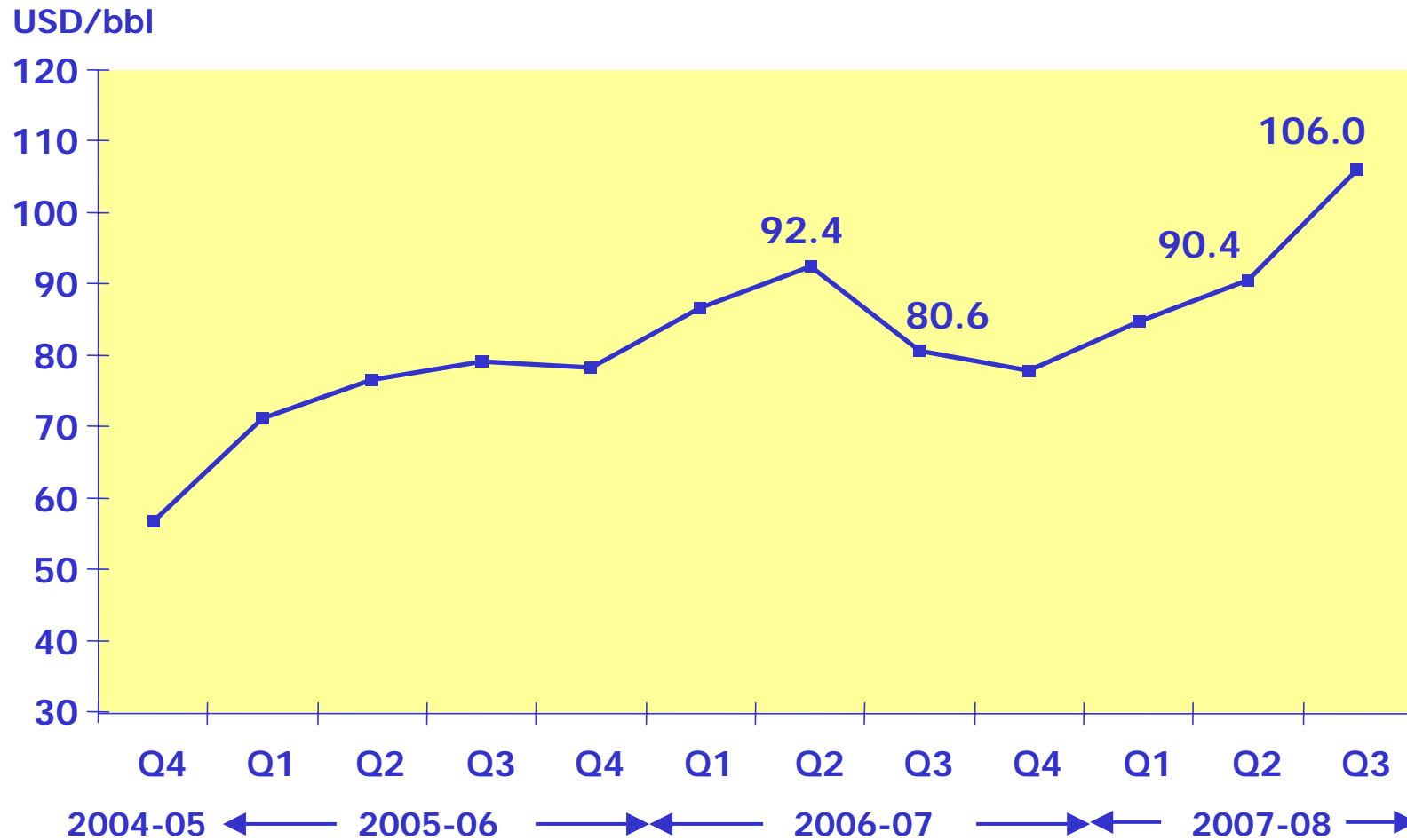
Top 5 Expenditure Breakdown

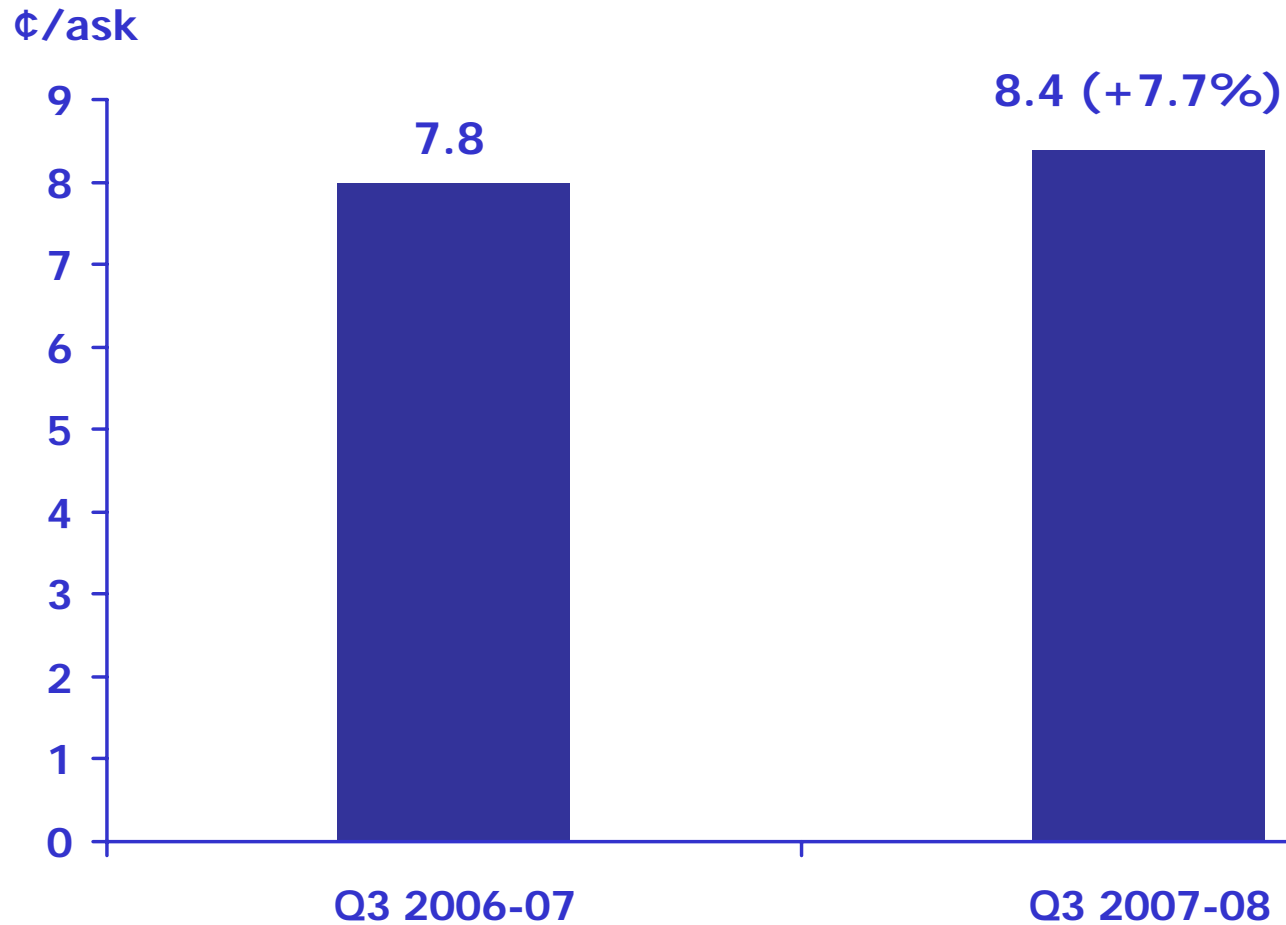
Fuel Price Before Hedging

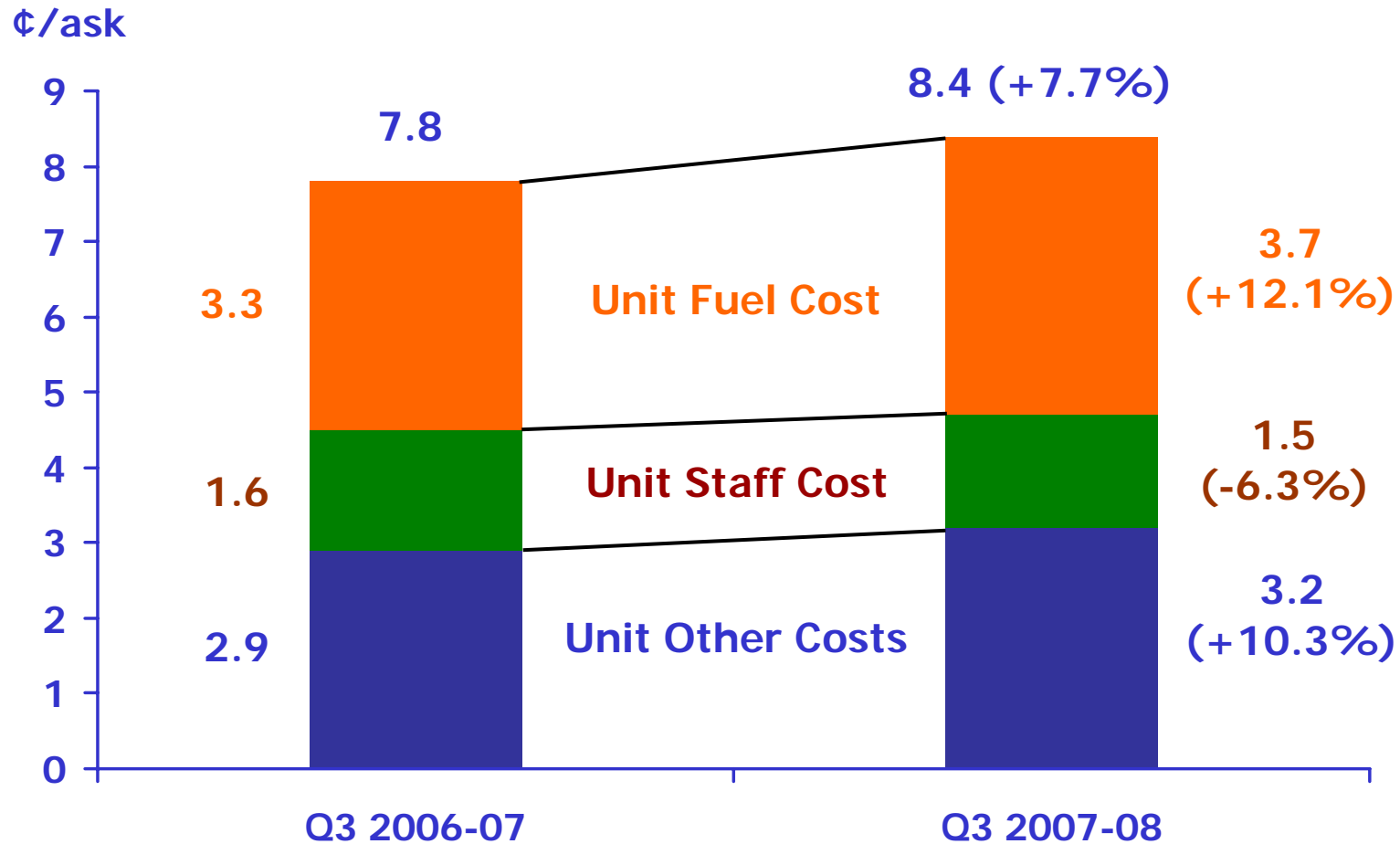
Passenger Unit Cost
