

**TERMS AND CONDITIONS FOR  
KRIS+ MILESTONE QUEST CAMPAIGN**

1. These terms and conditions govern the Kris+ Milestone Quest Campaign (the “**Promotion**”) organised by Kris+ Pte. Ltd. (“Kris+”). This campaign will be carried out on the Kris+ mobile application (“**Kris+ App**”).
2. The Promotion is applicable to all KrisFlyer members (“**Participants**”) who:
  - a. have downloaded the Kris+ Mobile Application (“**Kris+ App**”); and
  - b. have completed the Promotion’s enrolment condition as defined in clause 3 below; and
  - c. have carried out an “**Eligible Payment Transaction**” (as defined in clause 4 below) during the promotional period from 1 September 2024, 0000hrs (SGT) to 15 September 2024, 2359hrs (SGT) (the “**Promotional Period**”).

For avoidance of doubt, participants who do not satisfy any of the conditions above will not be eligible to enter the Promotion and will be disqualified despite having completed an Eligible Transaction.

3. To enrol into the Promotion, Participants need to access the “Kris+ Milestone Quest” challenge under the Kris+ challenge page and tap “Start now”. Participants must subsequently complete a transaction of SGD 5 min. spend in a single transaction at any “**Participating Kris+ Partner**” to complete enrolment to the Promotion (the “**Enrolment Transaction**”).
4. Participating Kris+ Partners include all merchants that accept payments through the Kris+ app via Apple Pay (for iOS devices) or Google Pay (for Android devices) in Singapore.
5. Subsequent to being enrolled in the Promotion, a Participant can make an “**Eligible Payment Transaction**” which refers to a payment of minimum SGD 5 using any form of payment methods, directly through the Kris+ App at any Participating Kris+ Partner other than the one involved in the Enrolment Transaction. An Eligible Kris+ Payment Transaction must be completed using the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Kris+ Payment Transaction is performed, as long as they are carried out within the Promotional Period.
6. For avoidance of doubt, transactions on Pelago and D’cuisines through the Kris+ app are not considered Eligible Kris+ Payment Transactions.
7. 100 bonus KrisPay miles (“**Discovery Bonus Miles**”) will be awarded (for each Eligible Payment Transaction made, up to a maximum of 500 bonus KrisPay miles. In addition, an Eligible Payment Transaction is only counted if it does not share the same Participating Kris+ Partner as previous Eligible Payment Transaction and as the Enrolment Payment Transaction during the Promotion Period (“**Unique brand visited**”).

- No bonus miles (i.e. Enrolment Transaction)
- Bonus 100 miles

6 or more unique brands visited

Bonus 400 miles  
Bonus 500 miles

8. For avoidance of doubt, the Discovery Bonus Miles quanta illustrated under clause 5 are not additive to each other.
9. Discovery Bonus Miles distributed in this Promotion and credited into an applicable Participant's KrisPay wallet can be transferred into the Participant's respective KrisFlyer account within 21 days of credit. Discovery Bonus Miles however are non-transferable to other Participants' KrisPay wallets, and cannot be exchanged or redeemed for cash.
10. By participating in the Challenge, each Participant:
  - a. agrees to comply with and be bound by these terms and conditions, Kris+'s conditions of use of website, Singapore Airlines' Privacy Policy, and the Kris+ Terms and Conditions (collectively, "Kris+ Terms & Conditions"). Non-compliance with or breach of any of these Kris+ Terms and Conditions may result in the participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed; and
  - b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, "Processed") by Kris+ for the purposes of organizing the Promotion and issuing the Prizes. All collection, use and disclosure of each Participant's personal data will be in accordance with Singapore Airlines' Privacy Policy (available online at [http://www.singaporeair.com/en\\_UK/privacy-policy/](http://www.singaporeair.com/en_UK/privacy-policy/)).
11. Kris+ reserves the right to vary these terms and conditions, amend the list of Participating Kris+ Partners in which Eligible In-App Payment Transactions may be made, and terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
12. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
13. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant's acceptance of any prize.
14. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of the Award.
15. These terms and conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
