TERMS AND CONDITIONS FOR KRIS+ NATIONAL DAY MILES-BACK PROMOTION

These terms and conditions ("**Terms and Conditions**") govern the Kris+ National Day Miles-Back promotion (the "**Promotion**") organised by Singapore Airlines Limited ("**SIA**"). This Promotion will be carried out on the Kris+ mobile application ("**Kris+ App**").

- 1. The Promotion is applicable to all KrisFlyer members who have performed a Kris+ Redemption Transaction during the Promotional Period (as defined in paragraph 2) ("Participant"). For the purposes of these Terms and Conditions, a "Kris+ Redemption Transaction" means any single transfer of at least SGD0.10 or 15 KrisPay miles made to any Kris+ partner in Singapore by a Participant using KrisPay miles on the Kris+ App, regardless of the type of mobile device from which such redemption transaction is performed, within the Promotional Period (as defined in paragraph 2), save for transactions carried out by KrisFlyer members in connection with effecting a successful referral and accrual of rewards under the Kris+ Referral Programme.
- 2. The Promotion commences on 26 July 2023, 0000 hrs (Singapore time) and ends on 13 August 2023, 2359 hrs (Singapore time) ("**Promotional Period**").
- 3. Participants will receive KrisPay miles back based on the percentage of the actual number of KrisPay miles transferred as follows:

KrisPay miles Transferred Partner	to	Kris+	Miles-Back (%)
15 miles (SGD 0.10) and above			25% of the KrisPay Miles transferred to the Kris+ Participant (rounded down to the nearest whole number)

- 4. After each qualifying Kris+ Redemption Transaction has been completed, the resulting KrisPay miles back will be credited into the Participant's Kris+ account instantly. Such KrisPay miles shall be valid for 6 months from the date of credit.
- 5. Kris+ Partners reserve the right to reject any splitting of the KrisPay miles transferred to them. A single receipt qualifies Participant to make one (1) transfer of KrisPay miles to Kris+ Partner.
- 6. KrisPay miles credited into an applicable Participant's KrisPay account by way of paragraphs 3 and 4 can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other Kris+ accounts and cannot be exchanged or redeemed for cash.
- 7. By participating in the Promotion, each Participant:
 - a. agrees to comply with and be bound by these Terms and Conditions, SIA's conditions of use of website, SIA's Privacy Policy, KrisFlyer Terms and Conditions, and the Kris+Terms and Conditions (collectively, "SIA Terms & Conditions"). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the Participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn, or reclaimed and
 - b. agrees that any and all personal data collected in this Promotion (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, "Processed") by SIA for the purposes of organizing the Promotion. All collection, use and disclosure of each Participant's personal data will be in accordance with SIA's Privacy Policy available at https://www.singaporeair.com/en_UK/privacy-policy/.

- 8. All decisions made by SIA, in respect to any matter relating to this Promotion shall be final. SIA reserves the right to vary these Terms and Conditions and/or the SIA Terms & Conditions at any time, amend the list of Kris+ Partners in which eligible Kris+ Redemption Transactions may be made, terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
- 9. SIA reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
- 10. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant's acceptance of any prize
- 11. Unless otherwise specified, SIA is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of any Prize.
- 12. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
- 13. A person who is not a party to these Promotion Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Promotion Terms and Conditions.
- 14. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
