

## TERMS AND CONDITIONS FOR SPEND & WIN CAMPAIGN

1. These Terms and Conditions govern the Kris+ Spend & Win Campaign (the “**Promotion**”) organised by Singapore Airlines Limited (“**SIA**”).
2. The Promotion is applicable to all KrisFlyer members (“**Participants**”) who:
  - a. have downloaded the Kris+ Mobile Application (“**Kris+ App**”); and
  - b. have carried out an Eligible Payment Transaction (as defined in clause 3 below) during the promotional period from 14 August 2023, 0000hrs (SGT) to 27 August 2023, 2359hrs (SGT) (the “**Promotional Period**”).
3. An “**Eligible Payment Transaction**” refers to a transaction falling on a date and time within the Promotional Period in which a Participant makes a payment of a minimum amount of SGD 10 via Apple Pay, Google Pay™, or KrisPay miles or any combination of these via the payment function in the Kris+ App at any Kris+ Partner with Kris+ payment enabled (“**Participating Kris+ Partner**”). All Eligible Kris+ Payment Transactions must be completed using the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Kris+ Payment Transactions are performed, as long as they are carried out within the Promotional Period.
4. Participating Kris+ Partners include all merchants that accept payments through the Kris+ app via Apple Pay (for iOS devices) or Google Pay (for Android devices). For avoidance of doubt, transactions on Pelago and ChoPe accessed through the Kris+ app are not considered Eligible Kris+ Payment Transactions.
5. Each Eligible Payment Transaction made during the Promotion Period entitles each Participant to one (1) chance to participate in the Promotion. An illustrative example of the accrual of such chances is set out in the table as follows:

6. After successfully completing an Eligible Payment Transaction, eligible Participants will be entitled to one (1) chance to participate in the Kris+ Question Game (the “**Game**”), provided that each Participant shall not be entitled to more than one (1) chance to participate in the Game for any goods or services (including food items and dine-ins at food and beverage outlets) purchased on a single occasion but split into different payment transactions or receipts (“the **Proviso**”). Without prejudice to any other rights or remedies it may have, SIA reserves the right to (i) forfeit any Game chances obtained by any Participant in contravention of the Proviso, and (ii) to forfeit the whole or part of any amount of KrisPay miles credited to any Participant as a result of any utilization of Game chances obtained in contravention of the Proviso.
7. Game chances will be stored and accumulated in the ‘Wallet’ tab under Kris+ Games. Participants may begin the game by (i) tapping on ‘Win a Prize’ to launch the Kris+ Question Game followed by ‘Start’; and(ii) select one of the 9 “options” on the game screen. Each Participant will randomly be assigned a Prize for each option selection made in the game. The game screen on the Kris+ App will inform the Participant of their respective prize won from the Game.
8. All Game chances received must be redeemed before the end of the Promotion Period, or the game chance will be forfeited.
9. Participants who have won a Prize will receive one (1) of the following amounts of KrisPay miles as set out below, which will be instantly credited into such Participant’s respective Kris+ accounts:

- (i) 3,000 KrisPay miles (worth SGD 20);
  - (ii) 1,500 KrisPay miles (worth SGD 10);
  - (iii) 600 KrisPay miles (worth SGD 4);
  - (iv) 300 KrisPay miles (worth SGD 2); or
  - (v) 150 KrisPay miles (worth SGD 1)
10. All KrisPay miles distributed in this Promotion and credited into an applicable Participant's KrisPay wallet can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other KrisPay wallets, and cannot be exchanged or redeemed for cash.
11. All KrisPay miles awarded in this Promotion are valid for a period of six (6) months from the date on which they are credited into the Participant's KrisPay wallet, following which they shall expire and no extensions will be permitted.
12. By participating in the Promotion, each Participant:
- a. agrees to comply with and be bound by these Terms and Conditions, SIA's conditions of use of website, SIA's Privacy Policy, and the Kris+ Terms and Conditions (collectively, "**SIA Terms & Conditions**"). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the Participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed; and
  - b. agrees that any and all personal data collected in this Promotion (including his/her KrisFlyer membership number, full name and mailing address) may be collected, used, disclosed, or otherwise processed (collectively, "**Processed**") by SIA for the purposes of organizing the Promotion and issuing the Prizes. All collection, use and disclosure of each Participant's personal data will be in accordance with SIA's Privacy Policy (available online at [http://www.singaporeair.com/en\\_UK/privacy-policy/](http://www.singaporeair.com/en_UK/privacy-policy/)).
13. All decisions made by SIA, in respect of all matters relating to the Promotion, including the choice of the Winner(s) shall be final. SIA reserves the right to vary these Terms and Conditions and/or the SIA Terms & Conditions at any time, amend the list of Participating Kris+ Partners in which Eligible Payment Transactions may be made, or terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
14. SIA reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
15. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion, playing the Game, or the participant's acceptance of any prize.
16. Unless otherwise specified, SIA is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of any Prize.
17. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
18. A person who is not a party to these Promotion Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Promotion Terms and Conditions.

19. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
