

TERMS AND CONDITIONS FOR KRIS+ SIGN-UP OFFER CAMPAIGN

1. These Terms and Conditions govern the Kris+ Sign-Up Offer Campaign (this “**Promotion**”) organised by Kris+ Pte Ltd (“**Kris+**”).
2. This Promotion is open to all KrisFlyer members (“**Participants**”) who:
 - a. have downloaded the Kris+ Mobile Application (“**Kris+ App**”) after 0000 hrs (AEDT) 20 November 2023; and
 - b. have carried out an Eligible Payment Transaction (as defined in clause 3 below) during the promotional period from 20 November 2023, 0000hrs (AEDT) to 31 December 2023, 2359hrs (AEDT) (the “**Promotional Period**”).
3. An “**Eligible Payment Transaction**” refers to a transaction falling on a date and time within the Promotional Period in which a Participant makes a payment of a minimum amount of AUD \$15 via Apple Pay or Google Pay™, via the payment function in the Kris+ App at any Kris+ Partner in Sydney or Melbourne with Kris+ payment enabled (“**Participating Kris+ Partner**”) for the first time. All Eligible Payment Transactions must be completed using the Kris+ App and will be valid regardless of the type of mobile device from which such Eligible Payment Transactions are performed, as long as they are carried out within the Promotional Period.
4. The first 2,000 Participants who have carried out an Eligible Payment Transaction during the Promotional Period will receive the following rewards based on the following criteria:
 - a. Participants who have carried out only one (1) Eligible Payment Transaction during the Promotional Period will receive 1,000 KrisPay miles on 22 January 2024 (“**Reward 1**”); and
 - b. Participants who have carried out at least two (2) Eligible Payment Transactions (each at a different Participating Kris+ Partner) during the Promotional Period will receive a total of 2,000 KrisPay miles on 22 January 2024 (“**Reward 2**”). Reward 1 and Reward 2 shall together be referred to as the “**Rewards**”.
5. Each KrisFlyer member is eligible to receive only one (1) Reward under this Promotion, depending on the total number of Eligible Payment Transactions made during the Promotional Period.
6. All KrisPay miles awarded from this Promotion and credited into an applicable Participant’s KrisPay wallet can be transferred into his/her Participant’s KrisFlyer account within 7 days from the date on which they are credited into the Participant’s KrisPay wallet. The Rewards are non-transferable to other KrisPay wallets, and cannot be exchanged or redeemed for cash.
7. All KrisPay miles awarded from this Promotion that are retained in Participant’s KrisPay wallet are valid for a period of six (6) months from the date on which they are credited into the Participant’s KrisPay wallet, following which they shall expire and no extensions will be permitted.
8. By participating in this Promotion, each Participant:
 - a. agrees to comply with and be bound by these Terms and Conditions, Kris+’s conditions of use of its website, Kris+’s Privacy Policy, and the Kris+ Terms of Use (collectively, “**Kris+ Terms & Conditions**”). Non-compliance with or breach of any of these Kris+ Terms and Conditions may result in the Participant being disqualified at any stage of this Promotion, and any Reward won may be forfeited, withheld, withdrawn or reclaimed, each at Kris+’s sole and absolute discretion; and
 - b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number, full name and mailing address) may be collected, used, disclosed and/or otherwise processed (collectively, “**Processed**”) by Kris+ for the purposes of

organizing this Promotion and issuing the Prizes. All collection, use and disclosure of each Participant's personal data will be in accordance with the SIA Privacy Policy (available online at http://www.singaporeair.com/en_UK/privacy-policy/).

9. All decisions made by Kris+, in respect of any matter relating to this Promotion, including the choice of the recipient of the Reward, shall be final. Kris+ reserves the right to vary these Terms and Conditions and/or the Kris+ Terms & Conditions at any time, amend the list of Participating Kris+ Partners in which Eligible Payment Transactions may be made, or terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
10. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry.
11. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in this Promotion, or the participant's acceptance of any Reward.
12. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in this Promotion and/or with the use or redemption of any Reward. Kris+ will also not be responsible for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment), or that results in an infringement of any law or regulation, by participating in this Promotion.
13. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to this Promotion, these Terms and Conditions shall prevail to the extent of such inconsistency.
14. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these Terms and Conditions.
15. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
