

**TERMS AND CONDITIONS FOR
KRIS+ 30% BONUS MILES PROMO**

These terms and conditions (“**Terms and Conditions**”) govern the Kris+ 30% bonus miles promotion (the “**Promotion**”) organised by Kris+ Pte. Ltd. (“**Kris+**”). This Promotion will be carried out on the Kris+ mobile application (“**Kris+ App**”).

1. The Promotion commences on **09 September 2024, 0000 hrs (Singapore time) and ends on 30 September 2024, 2359 hrs (Singapore time)** (“**Promotional Period**”).
2. The promotion applies to all KrisFlyer members who have successfully completed a **Kris+ Transfer Transaction** during the Promotion Period (“**Participant**”):
 - a. For purposes to these Terms and Conditions, a “**Kris+ Transfer Transaction**” refers to a transaction by a Participant that effects a transfer of a minimum of 15 KrisFlyer miles from their KrisFlyer account into such Participant’s Kris+ account, through the Kris+ app, regardless of the type of mobile device from which such transaction is performed.
3. Participants who successfully carry out a Kris+ Transfer Transaction within the Promotional Period, will be entitled to receive bonus KrisPay miles (“**Bonus**”), which will be credited directly into the Participant’s Kris+ account instantly. The quantum of the Bonus will be based on 30% of the actual number of KrisFlyer miles transferred to Kris+ as part of the qualifying Kris+ Transfer Transaction, rounded to the nearest whole number. An illustration is as follows:

No. of miles transferred from KrisFlyer to Kris+	No. of resultant KrisPay miles in Kris+ (Without Promotion)	No. of resultant KrisPay miles in Kris+ (With Promotion)
14 KrisFlyer miles	14 KrisPay miles	14 KrisPay miles
15 KrisFlyer miles	15 KrisPay miles	20 KrisPay miles
150 KrisFlyer miles	150 KrisPay miles	195 KrisPay miles

4. Bonus KrisPay miles shall be valid for 6 months from the date of credit, can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. Bonus KrisPay miles are also non-transferable to other Kris+ accounts and cannot be exchanged or redeemed for cash.
5. By participating in the Challenge, each Participant:
 - a. agrees to comply with and be bound by these terms and conditions, Kris+’s conditions of use of website, Singapore Airlines’ Privacy Policy, and the Kris+ Terms and Conditions (collectively, “**Kris+ Terms & Conditions**”). Non-compliance with or breach of any of these Kris+ Terms and Conditions may result in the participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed; and
 - b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise processed (collectively, “**Processed**”) by Kris+ for the purposes of organizing the Promotion and issuing the Prizes. All collection, use and disclosure of each Participant’s personal data will be in accordance with Singapore Airlines’ Privacy Policy (available online at http://www.singaporeair.com/en_UK/privacy-policy/).

6. All decisions made by Kris+, in respect to any matter relating to this Promotion shall be final. Kris+ reserves the right to vary these Terms and Conditions and/or the Kris+ Terms & Conditions at any time, amend the list of Kris+ Partners in which eligible Kris+ Redemption Transactions may be made, terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
7. Kris+ reserves the right to verify the eligibility of Participants. The demise of a Participant automatically disqualifies his/her entry
8. Kris+ reserves the right to vary these terms and conditions, amend the list of Participating Kris+ Partners in which Eligible In-App Payment Transactions may be made, and terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
9. To the extent permitted under applicable law, Kris+ will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant's acceptance of any prize.
10. Unless otherwise specified, Kris+ is not responsible for and will not bear any and all expenses and ancillary costs which may be incurred in the participation in the Promotion and/or with the use or redemption of the Award.
11. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
12. A person who is not a party to these Promotion Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these Promotion Terms and Conditions.
13. These terms and conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
